The Board of Education would like to recognize and congratulate Katharine "Kate" Dusenbury, a senior at Fruita Monument High School, for scoring perfect on the ACT in the spring of 2008. Kate is one of only 22 students in the state of Colorado to score perfectly this year. The ACT assesses high school students' general educational development and their ability to complete college-level work. In Colorado, all juniors in high school are required to take the ACT as part of the state accountability system.

Surprisingly, Kate didn't study specifically or take practice tests in preparation for the ACT. With a healthy breakfast and a good night's sleep, Kate was able to achieve this outstanding feat on her own merit. Her attitude that tests should not be intimidating or scary allowed her focus on answering the questions, and not on the importance of the test as a whole. Going into the test, Kate took a vital piece of advice from her father as well, that the answer is always right in front of you. Keeping that in mind, the perfect score was very much in reach.

Kate draws on her family for inspiration in all her academic pursuits. She specifically states that her older brother Jed has had a huge impact on her academic career, always pushing her to be better, to find the motivation to try her hardest. She will be taking that approach to higher education, where she plans on attending a small liberal arts school out of state.

Kate and her fellow achievers were honored by the Colorado State Board of Education and College in Colorado last week. A perfect score is extraordinary—only one in every 5,500 students nationally will reach that level. These 22 students, including Kate, certainly deserve to be recognized as terrific examples of what Colorado can achieve. The Board of Education would like to congratulate Kate and wish her luck in her future endeavors.
