He stated there would be two topics for discussion tonight. 1. Unified Improvement Plan (UIP) Report and Performance Based Learning Presentation and Discussion. Chief Academic Officer, Mr. Tony Giurado, and Mr. Steve Schultz presented an update on the District's Unified Improvement Plan (UIP) and on plans to pilot schools with regards to Student Driven Learning. Mr. Giurado reported the roadmap to the 21st century required District 51 to improve instruction, curriculum, technology and facilities. It also required the District to change its statement from, "we do pretty well for one of the lowest funded districts in the state," to state "we are the breakthrough district, which is leading the state in making significant student growth." Mr. Giurado spoke of overcoming challenges to achieve the success we desire. He shared research from Marzano and Waters on what elements have the greatest effect on student learning. The research guides us to leveraging what works: Effective teachers have the single most significant impact on learning Effective principals have a significant impact on learning Effective district leadership has a significant impact on learning With this in mind, Mr. Giurado stated the organization should invest in professional development to ensure District 51 teachers are as effective and prepared as possible. Mr. Giurado reported on the District's internal audit of strengths and weaknesses. The audit revealed the District is asking teachers to do too much and the District needs to improve systems support for educators. District 51 should support teachers by assisting them with: Colorado Academic Standards **Unified Curriculum** Reporting tools Learning targets, and Success Criteria Mr. Schultz reported Student Driven Learning is an instructional innovation which focuses on mastery of content as a basis for student progression instead of student seat time. He stated it replaces age-based grade levels with content levels. As students' progress through content levels at their own pace, they will optimize their level of engagement and motivation. Teachers will serve as instructional coaches, providing tailored supports based on unique learning goals and the needs of every student. Student Driven Learning improves learning because students work at their pace and advance based on mastery, not age, or number of days in school. Mastery requires students to apply and demonstrate what they've learned. Students can be on a variety of content levels in different subjects and advanced students are challenged and can move ahead. Struggling students get support to advance at their own pace. Students do not advance without the skills to succeed. The District is planning to pilot Student Driven Learning. This

involves a series of complex, successive steps beginning with:

Phase 1: Foundational design, communications, and measurable metrics.

						 Phase 2: Pilot schools begin to utilize and refine more components, study schools may expand to full pilot schools and data is collected to guide decisions for broader implementation. Phase 3: Pilot schools become demonstration schools. District 51 leadership is working with schools to identify participating pilot and study schools. This work will involve thorough communications and meetings with 	
						study schools. This work will involve thorough communications and meetings with staff at those schools so they may understand the scope of their commitment. Study schools will participate in professional development, but not actively pilot the approach. The Pilot will begin in August, 2015.
