Dear Ms. Allen:

This firm represents Mesa County Valley School District No. 51 ("District"). We are responding on the District's behalf to your letter dated January 28, 2019 addressed to Vi Crawford, the District's Director of Financial Services. In that letter you request to inspect or obtain copies of certain documents under the Colorado Open Records Act. Specifically, you request that the District provide the following:

"the names of all the school district employees along with their district position or title and their individual annual salaries or yearly compensation for the school years 2017-2018 and 2018-2019. If you do not have a document that includes all three things with name, position, and salary, then two separate documents will suffice."

The District has no available documents, separately or in combination, that are responsive to your request. However, the District will, upon your request, assign staff to compile and manipulate personnel and financial data and generate a report not used by the District that contains the requested information. The District estimates that approximately six (6) hours of staff time will be required to complete this report.

Pursuant to District regulation KDB-R, the current fee for staff time spent in generating a report not used by the District is \$30.00 per hour for every hour in excess of one (1) hour. Therefore, the District estimates that the fee to produce the report will be at least \$150. The fee will not be waived.

Please advise in writing whether you still desire the District to proceed to generate a report containing the requested information. If you advise the District to proceed, once the report is available we will notify you as to the actual charges associated with the generation of the

report, and will transmit it to you when we have confirmed that the District has received payment in full of those charges or you have made arrangements acceptable to the District for payment in full of those charges.
